Subject: Revised dates for Registration and Confirmation; Compartmental and Improvement Examinations.

Dear Principal,

The Council has received several emails from Heads of Schools regarding the genuine difficulty being faced by them to collate information and to make payments for the Confirmation and Registration of the candidates for the 2021 & 2022 ICSE / ISC Examinations due to the unprecedented situation created by COVID 19 pandemic.

In view of the present situation, the Council has decided to review its earlier stand and to extend the dates as per details mentioned below:

- (i) **ICSE Registration & Confirmation of Entries** – For the ICSE Registration & Confirmation of Entries, the revised last date will be **September 15, 2020** without late fees and **September 30, 2020 (with late fees)**
- (ii) **ISC Eligibility, Registration and Confirmation of Entries**– For ISC Eligibility, the revised last date will be **September 15, 2020** and revised last date for ISC Registration of Candidates will be **September 30, 2020**.

For **ISC Confirmation of Entries**, the revised last date will be **September 15, 2020** without late fees and **September 30, 2020 (with late fees)**

Please be informed that no further extension of dates will be given in this regard.

In addition, please note the following:

- (iii) **Compartmental Examinations** – the Compartmental Examinations for both ICSE & ISC is scheduled **tentatively** be held in **November 2020** subject to conditions being conducive or may otherwise be held **with the regular examinations for the year 2021**. Such **Class X candidates may be provisionally be admitted to Class XI but will be registered only after successfully passing the ICSE Examination.**

- (iv) **Improvement Examinations** – The Improvement Examinations (for the ICSE / ISC 2020 candidates awarded imputed marks) may be held in **November 2020**, along with the **Compartmental Examinations**, subject to the conditions being conducive or **may otherwise be held along with the regular examinations for the Year 2021.**

The Registration for Improvement and Compartmental Examination modules will be activated for schools from 15th to 30th September 2020.

Schools may refer to the Council Circular dated 26th June 2020 which states:

“If the situation is deemed conducive, in the near future, CISCE may give an option to candidates to write any or all of the remaining papers of the ICSE / ISC Year 2020 Examinations at a later date whereby the marks so obtained by the candidate in that written examination(s) shall be considered as their final marks.”
